In Chapter 7 cases, your completion certificate is required to be filed with the Court not more than 60 days after your 341 meeting with the bankruptcy trustee. In Chapter 13 cases, your certificate is required to be filed prior to completion of the plan payments. In both cases, we strongly recommend that you complete the financial management course within a few days after filing your case.

For your convenience, we have contracted with Abacus Credit Counseling to meet your post-filing financial management requirement. You are not required to use Abacus, but their services are convenient and web-based. If you wish to choose an alternative provider, please let us know. Information on Abacus' courses is attached.
